
Congratulations to our College Class of 2024!

When AIR was formed, the enrollment of Native students, at major university across the nation, was less than 1%. Unfortunately, this is still the case today. Higher education for Native people has historically been limited, offering fewer opportunities or choices. Often, our only option has been community college which is valuable, but we often saw greater opportunities for our non-native counterparts who could pursue higher education at a university of their choice.

AIR Peer Desicion Maker Traingings (peer jurist):

We had a fantastic turnout at the October Peer Decision Maker (PDM) Training Workshop. Our Honors Program courses and training workshops provide a comprehensive understanding of tribal restorative justice ideals. They provide our participants with knowledge of the Intertribal Court, the Tribal Youth Court, and the broader experience and expectations associated with being a PDM. The primary objective of the training is to prepare participants for their duties as peer jurors.

Upon completion, our participants will receive a Certificate of Completion and are able to serve as PDMs (jurists) within our Tribal Youth Court, earning community service for their dedicated time during the training.

Thank you to all our participants and are excited to welcome those of you who will be joining us within our Tribal Youth Court.

AIR / ICSC Moot Court Final (December 2023)

AIR Programs and the Intertribal Court of Southern California have been collaborating on a joint project focused on developing a Tribal Youth Court, with both prevention and intervention components. This initiative aims to intervene when our Native Youth have incidence of destructive actions. We accomplish this through a Tribal based Peer Court model (of diversion) where our Native Youth can give input, as peers, to help foster wellness for our court participants. As to our prevention side, we offer training for the youth peer court jury through restorative justice concepts in what we call our Honors Program. These courses/trainings cover topics within Tribal restorative justice and governance, as well as general knowledge of the US legal system. These courses are designed to help students understand Tribal restorative justice ideals and apply this within our Native Youth Peer Court.

In our last course, Introduction to Tribal Legal Studies, our students participated in a moot court, where they argued the court case, Haaland v. Brackeen, 599 U.S. (2023). We were proud of them as they demonstrated great academic skill, presentation proficiency, and knowledge of the subject with great confidence to our moderators and judges.

We want to express our heartfelt gratitude to all the students, parents, and volunteers for their participation, hard work, and commitment to this important initiative.

Dream the Impossible (April 2024)

We are very proud that we have been able to partner with so many organizations as each of us are part of our Native Communities that are needed for the success of our Native Youth. We recently presented on our AIR Programs projects. Highlighting this is our collaborative work with Intertribal Court and our Tribal Youth Court Project. Overall, we had a packed house during our 4 sessions. Thank you to all that have come to hear about what we do.



AIR Programs Fall 24 Honors Courses Accepting Applications Now

The Tribal Youth Court (TYC) project, is a diversion-based project that serves our San Diego County Tribes challenged with incidents of juvenile delinquency. The Intertribal Court of Southern California (ICSC) has developed a Native Youth Peer Diversion Court, where Native Youth will have the opportunity to hear and assist in the adjudication process of the juvenile offenders. To accomplish this, American Indian Recruitment (AIR), along with ICSC, has developed the Native Youth Peer Decision Makers (Peer Decision Makers) training project that will engage our Youth Decision Makers and guide them in their decisions within the Youth Court.

This Fall we are collaborating with UCSD to offer two courses, Intro to Legal Systems, 1 unit, and the Introduction to Tribal Legal Studies, a 3-unit course. These courses provide a broad overview of the most important issues involved in US Based Law and Tribal legal studies, including an overview of tribal government, the history of tribal court systems, legal structure of tribal courts, tribal court criminal and civil jurisdiction, roles in tribal court systems, due process, appellate courts, the Indian Civil Rights Act, Public Law 280 and the Indian Child Welfare Act. Students receive an introduction to the basic concepts of legal studies with emphasis within contemporary tribal legal issues. The course addresses tribal common law and traditional dispute resolution methods, including the examination of the incorporation of custom and tradition into the Tribal court system.

This course will be online and mentor assistance will be provided to the students.

Initially our collaboration started with the concept of utilizing existing university level courses that were based in Tribal Law and Governance and adapted them for our Native youth. We had great success in our implementation of this program. In 2019, we were afforded the opportunity to further engage our Native youth with our more recent community-based partners (ICSC/UCSD/ SDSU and Palomar College) in training the Peer Decision Makers for the Tribal Youth Court. Here, they utilize their knowledge in restorative justice to participate as a peer jurist within the Tribal Youth Court at Intertribal Court of Southern California located on the Rincon Reservation.

We show our passage rates which demonstrates our students understanding of the topics and their success in taking advanced university coursework.



What are students gaining through this? They are gaining the following:

• Students are gaining Academic credits at the universities in American Indian Studies

- Students are gaining dual credit at most (not all) High Schools based on articulation policies of the school district
 - Students are gaining knowledge in Tribal Restorative Justice ideals, Tribal Governance and Leadership
- Our Youth Peer Court collaboration is creating an extensive pool of Peer Decision Makers who may utilize this as community service
 - Students are gaining a second look within university admissions based on university coursework
